A. Background:

The West Bengal State Coastal Zone Management Authority (WBSCZMA) is functioning under Department of Environment, Govt. of West Bengal and is carrying out various works related to the coastal zone. The Coastal Regulation Zone (CRZ) maps and reports which are prepared for the clients are placed before the SCZMA for getting clearance.

B. Objective:

The purpose of the assignment is primarily to verify maps for different projects in and outside the State of West Bengal. In order to meet the objectives, the incumbent will be required to interact with stakeholders, officials of various Government Departments and calling various meeting, preparation of agenda and minutes of the meeting, making liaison with MoEFCC, GoI as per need.

C. Terms of Reference for engaging Scientist - JRF:

- a) Scientist - JRF will be required to study satellite images, maps, survey reports etc.
- b) Scientist - JRF will be required to interpret images, geomorphological signature and other features and co-relate images with other maps.
- c) Scientist - JRF will work on all CRZ related works and also all GIS related works taken up by the Authority.
- d) Scientist - JRF has to execute the works in a mission mode, so he/she may be required to work on Saturdays, Sundays, holidays and beyond office hours.
- e) Scientist - JRF will have to assist in any other works, in any other projects, as assigned to him/her by this office.

D. Other Details:

- 1) Name of the Post: Scientist – JRF.
- 2) No. of Post: 1 (One).
- 3) Tenure: One year initially, which may extend based on satisfactory performance and project requirement.
- 4) Remuneration: ₹ 25,000/- per month (Consolidated)
- 5) Age: Maximum 35 years as on 01/01/2023

E. Eligibility:

The Scientist - JRF should have:

- a) Master degree in Env. Science / Geography / Geology / Marine Science / Oceanography / Geophysics / Forestry & Wildlife / Earth Science and other related fields from any recognized University.
- b) Certificate / Degree / Diploma in any Geo-information (RS/GIS) course.
- c) Preferable two years' experience in GIS / RS applications, in coastal areas / related domain.

F. Selection:

Stage 1: Hands on experience regarding the ability to analyze the quality of data / report will be checked through computer based small exercise.

Stage 2: Successful candidates from Stage 1 will be interviewed.
