- Name of the Post** : SENIOR SCIENTIST (Remote Sensing and Geographical Information System)
- Number of Post** : 01 (One) - General
- Remuneration** : Rs. 1,10,000/- Per Month (Consolidated)
- Tenure** : 1 (One) year initially, may be renewed with the approval of Director.
- Qualification** : M.Sc. in related discipline like Remote Sensing & Geographical Information System / Geoinformatics / Geospatial Technologies.
- Experience** : **Essential** -
- (i) At Least 10 (Ten) years working experience in map/image interpretation using latest GIS software.
 - (ii) Candidates already employed in a State/Central Govt. Organization or State/Central Govt. Undertakings having minimum 07 (Seven) years' experience as Scientist may also apply for the post of Senior Scientist or a candidate having at least 10 years' experience working as Junior Scientist may also apply for the post of Senior Scientist.
- Desirable** -
- (i) Ph. D in relevant field.
 - (ii) Experience in planning and execution of scientific projects in a Research Organization in the relevant field.
 - (iii) Experience in HTL/LTL/CRZ/CZMP mapping procedures.
 - (iv) Publications in reputed journals.
- Age** : Upper age limit is 40 years as on 01/12/2023 subject to relaxation by 5 years for the Scheduled Castes and the Scheduled Tribes, 3 years for the Other Backward Classes category of candidates and 5 years for the Persons with Disabilities (having physical disabilities of 40% or above) and 10 years in case of long experience in this field.

Candidate must note:

- (i) Persons working in Government Offices/Public Sector Undertakings/Autonomous Organization should apply with No Objection Certificate (NOC) from the present employer during application.
- (ii) The applications should be sent in neatly typed out in A4 size paper. The information furnished in the application should be supported by relevant documents. Copies of all the certificates (duly self- attested) pertaining to the qualification, experience, date of birth, castes certificate etc. must be enclosed. A recent passport size photograph duly signed shall be pasted on the application.
- (iii) Candidates will have to produce the documents, in original, during interview and when required for verifying the documents furnished by them with their application.
